V. Health Attestation

I, the undersigned official veterinarian, certify that:

- the porcine serum products described above were manufactured from porcine blood of New Zealand origin
- 2. New Zealand is recognised by the OIE as being free from foot and mouth disease
- 3. New Zealand is free from African swine fever, classical swine fever, porcine reproductive and respiratory syndrome, swine vesicular disease and Aujeszky's disease
- The pigs from which the serum was derived have been subjected to both ante-and postmortem veterinary inspection and found to be free from signs of disease
- The blood of slaughtered animals, which is fit for human consumption in accordance with Union legislation, but is not intended for human consumption for commercial reasons. OR (delete as applicable.)
 - The blood of slaughtered animals, which is rejected as unfit for human consumption in accordance with Union legislation, but which did not show any signs of diseases communicable to humans or animals, derived from carcasses that have been slaughtered in a slaughterhouse and were considered fit for human consumption following an ante mortem inspection in accordance with Union legislation.
- 6. The blood from which such products are manufactured has been collected in slaughterhouses approved in accordance with Union legislation and supervised by the competent authority of the country of collection.
- 7. The blood / blood products were not commingled with any animal origin material not authorised by the country of origin and all precautions were taken to avoid contamination of the products with pathogenic agents after treatment.
- 8. The serum was irradiated at least at 25 kiloGray (kGy) or above at an approved facility
- 9. The bottles are labelled: "for research use only. Not for diagnostic or therapeutic use."
- 10. The products were packaged in new or sterilized bottles, bearing tamper-evident seals and labelled with lot/batch/catalogue numbers
- 11. Bottles were packed in new, clean styropor containers that are sealed with the following seal numbers......
